

Downtown Chandler Monthly Giveaway Terms & Conditions

- For the purposes of these Terms and Conditions, "The Promoter" refers to Discover Downtown Chandler whose Instagram handle is @discoverdowntownchandler. The "Prize" refers to \$150.00 in cash or prizes.
- By entering the competition you agree to be bound by these terms and conditions. All entries must be received before the last day of each month. One (1) winner will be selected at random by Discover Downtown Chandler on the 3rd of the following month and the winner will be notified on or after this date.
- Entry via Flex Rewards App by collecting 5 stamps and are open only to residents of the United States. One (1) winner will be chosen at random from all entrants and across the platform.
